1. NOTICE IS HEREBY GIVEN IN TERMS OF ARTICLE 12 (4) OF THE PAPU CONVENTION (Revised in 2018), and also, in line with Article 2.4 of the Rules of Procedure of the Administrative Council of the Union, that the 11<sup>th</sup> Extraordinary Session of the Pan African Postal Union Administrative Council will be held online on the 19<sup>th</sup> November 2025.
