**NOTICE OF THE 44<sup>TH</sup> ORDINARY SESSION OF THE PAN AFRICAN POSTAL UNION (PAPU) ADMINISTRATIVE COUNCIL FROM 23<sup>RD</sup> TO 24<sup>TH</sup> MARCH 2026, IN ENTEBBE, REPUBLIC OF UGANDA**

1. **NOTICE IS HEREBY GIVEN IN TERMS OF ARTICLE 12 (4) OF THE PAPU CONVENTION (Revised in 2018),** and also, in line with Article 2.4 of the Rules of Procedure of the Administrative Council of the Union, that the 44<sup>th</sup> Ordinary Session of the Pan African Postal Union Administrative Council will be held from 23<sup>rd</sup> to 24<sup>th</sup> March 2026, in Entebbe Republic of Uganda. The Session will be preceded by the Administrative and Technical Committee Meetings which will be held from 16<sup>th</sup> to 20<sup>th</sup> March 2026 at the same venue.
2. The PAPU Administrative Council consists of the following twenty-three (23) Member States:
  - **Central Africa:** Burundi, Cameroon and the Democratic Republic of Congo;
  - **Eastern Africa:** Ethiopia, Kenya, Madagascar, Sudan and United Republic of Tanzania;
  - **Northern Africa:** Algeria, Morocco and Tunisia;
  - **Western Africa:** Benin, Burkina Faso, Côte d'Ivoire, Niger, Nigeria and Senegal;
  - **Southern Africa:** Botswana, Eswatini, Malawi, Namibia, Zambia and Zimbabwe.
3. The Session will commence at 09:00 am (EAT) under the stewardship of the Bureau that was installed during the 43<sup>rd</sup> Ordinary Session of the Administrative Council. The current Bureau comprises the following Member States:
