All the meetings will have simultaneous interpretation in the Union's working languages, namely, English Language and French Language.

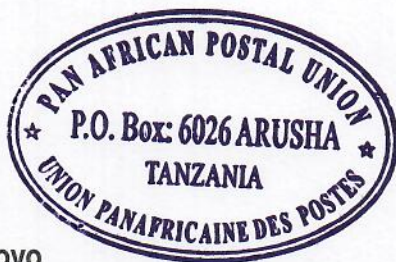
