I. INTRODUCTION

During the cycle 2021/2022-2025/2026, the Administrative Council considered several documents presented to it by the Policy and Regulation Committee. These documents led to the adoption of resolutions, decisions and recommendations on legal and policy matters, particularly the revision of the Union's Acts and adjustments to the functioning of the Union's bodies.
